Email Matsuru	<p>Dear Vice President, dear mister Nuvin Trilok Kumar and Esteemed Members of the JJIF Board,</p> <p>We're writing this letter and hope we can finally solve the problems between us.</p> <p>Matsuru and JJIF.</p> <p>Once again, we are sorry that there was a misunderstanding regarding the usage of the JJIF logo.</p> <p>It was never our meaning, to use the JJIF logo, we always used the JJEU logo.</p> <p>Unfortunately, the factory where we ordered the products, used the wrong logo.</p> <p>This was a one-time order of 500 pieces.</p> <p>All earlier orders and also the later orders have the JJEU logos.</p> <p>We have written several e-mails and tried many times to contact the JJIF by phone.</p> <p>At first, we didn't receive replies on several e-mails and/or telephone calls.</p> <p>We've asked many times what we can do to resolve this matter.</p> <p>We suggested to pay a fee, but as we understand you don't have a partner/sponsoring program.</p> <p>Then we suggested that maybe we can do something for you and at the same time helping some of the somewhat poorer countries.</p> <p>That we donate to the JJIF 300 Ju Jitsu gloves (150 red and blue)</p> <p>On that message we received an answer, and as we understand the JJIF liked that suggestion.</p> <p>We then tried to arrange a meeting, so that we could work this out further and have the opportunity to apologize in person. We wanted to come to Croatia Zagreb in November, due to circumstances that didn't happen.</p> <p>Then we agreed to meet at the Acropolis open in Greece. But as you know that was canceled so once again, we couldn't meet. After that the communication between us was once again silent.</p> <p>We sincerely hope that we can finally arrange something to resolve our problems.</p> <p>Matsuru is a partner/sponsoring the JJEU and we would like to continue that.</p> <p>And we also want to provide the Dutch national team our uniforms and equipment. So, our offer is still standing, or maybe you have a completely different idea. Then we would like to hear your proposal.</p> <p>In any case, we would very much like to resolve the problems that have arisen between the JJIF and Matsuru.</p> <p>We would really like to explain everything and discuss this matter in person, or by phone.</p> <p>We hope for a good outcome and await your response.</p>
7. African Championship

Email from Algeria received after the board meeting	<p>- not part of the meeting but for information :</p> <p><i>In the usual procedure for organizing an international event in Algeria, it is required to submit a file to the Algerian Ministry of Sports, approximately one year in advance to be able to benefit from financial aid from the State specifically for the event, and among the documents to be provided is the agreement of international sports institutions, namely JJIF and JJAFU. In this sense we asked Mr. Nuvin to send us a copy of the minutes of the general meeting of JJAFU, as an element which proves the agreement of JJAFU. Unfortunately Mr. Nuvin delayed sending the minutes until March, which delayed the study of our file at the ministry and consequently, the ministry did not grant us assistance to organize the African championship, and this puts us before two options:</i></p> <p><i>First option: And reintroduce a new request with the minutes of the assembly, and postpone the event until 2025 to benefit from assistance from the ministry.</i></p> <p><i>Second option: organize the African Championship in 2024 without financial assistance from the ministry, which involves reducing charges linked in particular to covering the costs of transport, accommodation and catering for officials and VIP members, which we hope that the JJIF will take charge as a form of support for the African championship.</i></p> <p><i>Best Regards.</i></p>

PAST

- General Assembly once a year
- *One or Two Board meetings per year to make decisions [often very long meetings which became ineffective as well]*
- The executive board [until 2016] makes all decisions in the meantime
- Many decisions made by president / General Secretary out of the need of daily duties
- Ratification by board or General Assembly



SINCE CORONA

- Regular monthly online meetings
- Operations and Administration prepare the decisions
 - Faster acting
 - More information
 - But many day to day work [operational] decisions with little effects
 - Participation in meetings getting more irregular as well due to higher
 - Work sometimes stuck waiting for the next meeting
 - Our stake- and shareholders must often wait for next meeting



ORGANIZATIONAL PLANNING AND EXECUTION IN THREE LEVELS - STRATEGIC, TACTICAL, OPERATIONAL





PROPOSAL

- Regular online meetings [all 2 or 3 month] for tactical/strategic decisions [with rough budget if possible]
- The day to day base decisions and prepared by Operations and taken together with the president
- Regular report about these activities [decision book] but not more often as weekly with “veto / need for discussion” option for board members – general updates per WhatsApp [?]
- Urgent decisions with major effect [tactical/strategic] by separate email or extraordinary board meeting
