6. Financial Report	
Discussion	<p>Introduction of software "Quickbooks" for accounting, Mr. Thumfart presented the balance sheet as of December 2023 to the Session.</p> <p><b>Financial Audit:</b> Based on the financial statements shared along with the supporting documents received from JJIF Accounting representative, the JJIF Auditors (Mr. Ahmed Janahi and Mr. Ricky Frowyn) conducted a sample-based review and analytical procedures and queries with the JJIF management member. Except for the fact that the payments are processed with a single authorized signatory whereby dual authorization is recommended for better control. The Auditors mentioned that nothing came to their attention to conclude that the financials of any irregular activity/reporting in the information provided for review. They also mentioned that overall, improvements internal control of the organization is necessary to ensure full compliance with respective rules and standards and financial transparency. Therefore, they highly recommend to implement standardized tracking for project-specific expenses, formalize approval process, document standardization of events and financial review of events.</p>

In 2023, we also got 2 ATFs from Mexico for Clenbuterol which were cases of contaminated meat and in 2024 there is one ATF for Furosemide from Kazakhstan which may be a case of



contaminated pharmaceutical product which is currently under investigation and we have entrusted this work to ITA.

Some cases have been disposed of and some are still under process.

We remind you that first and foremost, it is the responsibility of the Federation to address the issue of anti-doping. This is a member obligation.

Above all, it is for the sport, for a clean sport where you are looking after the health and safety of the athletes and you are also upholding the principles of fairplay towards other athletes who do not dope.

Then doping cases also have financial consequences which must be borne by the Federations in accordance with the JJIF Anti-Doping Rules. They have to pay for the JJIF's costs of the Results Management process. This can range from around US\$ 2,000 to US\$ 10,000 and even more.

For example, if a non-deserving athlete is stubborn and wishes and insists of having a hearing which is then heard before the JJIF Anti-Doping Hearing Panel which is the Independent Hearing Panel set up by the International Testing Agency and if he further wishes to appeal to CAS, the result management process can cost up to US\$ 10,000.

This is what JJIF has had to pay for a case of a Jordanian Athlete, Rana Qubaj, who after refusing an agreement proposed by JJIF, asked to be heard before the Independent Hearing Panel where she lost her case and then appealed to the CAS and then finally gave up. As per the JJIF rules, JJIF can recover all the costs incurred from the Federation.

Over the years, we find that in some countries, the cases are recurrent. We get cases from these same few countries practically every year.

Further, we have a couple of cases under hand at present where we see athletes participating in competitions whilst they are provisionally suspended or serving a ban i.e a period of Ineligibility.

All this leads us to believe that the Federations of these countries are not addressing or properly addressing the issue of doping. Federations have to take this matter very seriously.

They should educate and create awareness among their athletes and coaches or other Athlete Support Personnel.

They should also be very diligent and exercise great care and caution not to allow banned athletes from participating in competitions or training within the Federation sports facilities.

I draw your attention that we also have an anti-doping rule which provides that any person who aids or covers up or commits any act of intentional complicity in relation to the rule of prohibition against participation also commits an anti-doping violation rule.

So, the officers of Federations who are not diligent enough or do not exercise proper care and caution put themselves at great risk. The punishment is a minimum period of 2 years up to life-time ban depending on the seriousness of the violation.

Further the Federation should be concerned that such violations give a bad image to their Federation, to their country, to the sport and to JJIF.

JJIF is investing a colossal sum of money in anti-doping to have a clean Ju-Jitsu and, therefore, a clean Ju-Jitsu must be the prime consideration of our Federations.

At the level of the JJIF Board, given the situation explained above, we are discussing if we need to adopt measures or tougher measures towards Federations which have recurrent cases over the years and which do not seem to address the anti-doping matter properly.

### ANNUAL REPORT BY JU JITSU ASIAN UNION

The year 2024 has been a significant period for Ju Jitsu activities across Asia. Despite the challenges still posed to us by global pandemic as well as complicated economic and political landscape around the globe, Asian Ju Jitsu family is growing and showing commitment to promote our sport. This report highlights key achievements and future projects for Ju Jitsu in Asia.

#### Key achievements of 2024:

- Increased participation:** this year witnessed a surge in participation in Ju Jitsu events, tournaments and training sessions across the Asia. In Asian Championship 2022 we faced 263 athletes from 22 National Federations, in 2023 there were already 443 athletes from 28 Federations. This year we faced 409 athletes from 30 Asian countries in Asian Adult Championship and 683 athletes from 24 countries at Asian Youth Championship.  
We've also witnessed impressive participation at our new regional events:  
West Asian Championship – 171 entries from 9 countries  
Central Asian Championship – 570 entries from 6 countries  
South East Asian Championship – 410 entries from 6 countries  
East Asian Championship – 165 entries from 6 countries  
South Asian Championship – to be held in December 2024
- Introducing new JJAU events:** This year we first introduced to our Asian Family new JJAU events: Asian Youth Championship, West Asian Championship, Central Asian Championship, South Asian Championship, South East Asian Championship, East Asian Championship. The regional Championships were developed to providing athletes from Asian regions the platform to compete with strong opponents and grow their skills. These events are more easy to participate for Federations as the cost of logistics is less than for our major JJAU events and through this we provide more opportunities to compete at international level for those athletes who is not able to make it at Asian Championship.
- Successful Asian and International championships in our continent:** Asian Games in Hangzhou, SEA Games in Cambodia, Ju Jitsu World Championship in Mongolia, Asian Championship in Thailand, Asian Championship in UAE, West Asian. I would like to highlight the efforts that the Federations of respective countries has put into organizing this important event for our athletes to contribute from it in their mastership. This increasing number of events in Asia also shows us that the growth of Asian Ju Jitsu has been noticed internationally and on different levels.
- Development initiatives:** we continue fostering the development of Ju Jitsu all across the continent. We invest into organizing various program to enhance technical skills, coaching capabilities and organisational structures within Ju Jitsu community:
  - Referee courses
  - Antidoping seminars
  - Safeguarding seminars and policies
  - Matts and kimono program

In 2024 we worked across the JJAU Statute to ensure that it reflects good governance standards and is aligned to international best practises.

### 7. Communication with Federations, NOCs and Sport Ministries

JJAU Secretary General office is in permanent touch with all our member Federations as well as some NOCs and Sports Ministries. In 2024 we contacted more than 20 NOCs and Sports Ministers to assist our members with funding/participation in OCA Games/developing Ju Jitsu prestige in their countries.

### Future prospects 2025:

1. OCA Asian Youth Games in Uzbekistan and World Games in China
2. **Regional Championships 2025:** 5 new Championships introduced in 2024 are to have new additions in 2025
3. **Educational programs** is to be continued in 2024: we provide the opportunity to benefit from our courses during each of regional championship we are planning to have in 2024.

Looking ahead in 2025, we hope that our sustained efforts in organizing, hosting and supporting various events and educational projects will further elevate the importance of Ju Jitsu in Asian and contribute to its continued growth and development.

## **Subject: Review Financial Report for the Year 2023**

Dear Mr. Panagiotis Theodoropoulos JJIF president, JJIF Vice presidents, JJIF board members, Director General, Mr. Joachim Thumfart, presidents of the Continental Unions, members of the JJIRC and members of the member federations,

### **Executive Summary**

**Purpose:** This audit was conducted to assess compliance with financial and operational standards, review internal controls, and ensure adherence to donor and grant requirements.

**Objectives:** Our objectives of this audit include:

- Assessing the effectiveness of financial controls.
- Reviewing processes related to fundraising, donations, and volunteer management.

**Our Scope:** The audit covered activities, financial transactions, fundraising events, and donor management processes conducted for the specified audit period. Departments audited include Finance, Fundraising, and Programs.

**Our Methodology:** We used document review, sampling of financial transactions, interviews with staff, and an assessment of operational procedures.

**Standards Followed:** The audit follows the International Standards for the Professional Practice of Internal Auditing and the best nonprofit-specific practices.

**Conclusion:** Based on the financial statements shared along with the supporting documents received from JJIF accounting representative, we have conducted a sample-based review and analytical procedures and queries with the JJIF management member. Except for the fact that payments are processed with a single authorized signatory whereby dual authorization is recommended for better control, nothing came to my attention to conclude that the financials of any irregular activity/reporting in the information provided for review. Overall, improvements internal control of the organization is necessary to ensure full compliance with the respective rules and standards and financial transparency.

**Recommendations:** Implement standardized tracking for project-specific expenses, formalize approval processes, document standardization of events and review of events financial.
